

#### IV. Application/validity

- The Zeller-Karte is issued by the Citizens' Office upon application and presentation of the relevant proof (see II., the benefit certificates must not be older than 6 months).
- The Zeller-Karte is issued individually for each entitled person. Children under 6 years of age are registered on their parents' card. The Zeller-Karte is only valid in combination with an official photo ID.
- The Zeller-Karte is valid for 1 year from the date of issue and can be extended for a further year, provided that the requirements for issuance continue to be met.
- The Zeller-Karte is not transferable. Lost or stolen cards cannot be replaced within the period of validity. Changes that affect the Zeller-Karte (e.g. moving away from Radolfzell) must be reported to the issuing office.

# GUIDELINES FOR THE ZELLER-KARTE OF THE CITY OF RADOLFZELL AM BODENSEE

## I. You have your main residence in Radolfzell am Bodensee and live in a domestic community.

### II. Eligible persons

The city provides a Zeller-Karte to the following persons:

- Single-parent family with one or more children entitled to child benefit if their income threshold does not exceed € 50,000 gross per year (according to §2 paragraph 3 of the Income Tax Act EStG)  
→ Presentation of the last tax assessment
- Families with at least two children who are entitled to child benefit if their income threshold does not exceed € 70,000 gross per year (according to §2 paragraph 3 of the Income Tax Act EStG)  
→ Presentation of the last tax assessment
- Families with at least one child who are entitled to child benefit if their income threshold does not exceed € 60,000 gross per year (according to §2 paragraph 3 of the Income Tax Act EStG)  
→ Presentation of the last tax assessment
- Recipients of benefits to secure subsistence according to the Social Security Statute Book SGB II (employable deprived persons/Hartz IV)  
→ Presentation of the grant approval from the Job Centre

- Recipients of benefits to secure subsistence according to the Social Security Statute Book SGB XII (Social welfare & basic income support)  
→ Presentation of the grant approval for basic income support
- Persons entitled to benefits under the Asylum Seekers' Benefits Act (AsylbLG)  
→ Presentation of the grant approval for benefits for asylum seekers
- Recipients of housing benefit according to the Housing Benefit Act (WoGG)  
→ Presentation of the grant approval for housing benefit
- Recipients of the child benefit according to § 6a of the Federal Family Allowance Act (BKKG)  
→ Presentation of the grant approval for child benefit
- People with a degree of severe disability of 50  
→ Presentation of the severely disabled pass
- Families with one or more severely disabled children entitled to child benefit (degree of disability 50 or more) receive the Zeller-Karte regardless of the family's income.  
→ Presentation of the severely disabled pass

### III. Discounts

Holders of the Zeller-Karte receive the following discounts:
